

PROCEEDINGS OF THE BOARD OF SUPERVISORS
October 27, 1992

The Board of Supervisors of Cerro Gordo County met in regular session pursuant to adjournment. Present: Ermer, Urdahl and Nannenga.

Urdahl motioned, with Nannenga seconding, to approve minutes of the October 20th session and amend the agenda to omit the 10:30 a.m. presentation by the North Iowa Medical Center. Motion passed unanimously.
