

PROCEEDINGS OF THE BOARD OF SUPERVISORS

October 26, 1995

The Board of Supervisors of Cerro Gordo County met in regular session pursuant to adjournment. Present: Nannenga, Urdahl and Ermgr.

Urdahl motioned, with Ermgr seconding, to approve the minutes of October 19th and today's agenda with the deletion of Items C and E, the addition of a US West Contract, resolution regarding the North Iowa Law Enforcement Mutual Aid Agreement and Recycling for Rural Residents under contracts. Motion passed unanimously.

Ermgr motioned, with Urdahl seconding, to adopt **Resolutions 93-160, 93-161 and 93-162 for the sale of Drainage District 6; Drainage District 31, Lateral 1 Upper and Drainage District 31, Lateral 4 Upper warrants to the First State Bank of Thornton.** Motion passed unanimously.

Ermgr motioned, with Urdahl seconding, to adopt **Resolution 93-163, regarding removal of trees and brush from supervisor trustee drainage district right-of-ways.** Motion passed unanimously.

Ermgr motioned, with Urdahl seconding, to **appoint Art Fischbeck as the County's representative to the Sesquicentennial Commission.** Motion passed unanimously.

Ermgr motioned, with Urdahl seconding, to enter into an **Inmate Telephone Service Agreement with US West Communications.** Motion passed unanimously.

Urdahl motioned, with Ermgr seconding, to adopt **Resolution 93-164, addition of the City of Rudd to the North Central Iowa Law Enforcement Mutual Aid Agreement.** Motion passed unanimously.

Ermgr motioned, with Urdahl seconding, to enter into a **rural recycling agreement with the City of Rockwell.** Motion passed unanimously.

Urdahl motioned, with Ermgr seconding, to sign the **Settlement Claim for probate number 22608.** Motion passed unanimously.

Ermgr motioned, with Urdahl seconding, to close the public portion of the zoning hearing. Motion passed unanimously.

Urdahl motioned, with Ermgr seconding, to adopt **Resolution 93-165-1, Resolution 93-165-2 and Resolution 93-165-3, zone changes for Groh, Brumm and Pals.** Motion passed unanimously.

Ermgr motioned, with Urdahl seconding, to adopt **Resolution 93-166 and Resolution 93-167, Accepting Work and Levying Final Assessment for Baker's application to the On-Site Sewage Bonding program.** Motion passed unanimously.

Ermgr motioned, with Urdahl seconding, to adopt **Resolution 93-168 and Resolution 93-169, Accepting Work and Levying Final Assessment for Drydal's application to the On-Site Sewage Bonding program.** Motion passed unanimously.

Urdahl motioned, with Ermgr seconding, to adopt **Resolution 93-170 and Resolution 93-171, Accepting Work and Levying Final Assessment for Brunsett's application to the On-Site Sewage Bonding program.** Motion passed unanimously.
