PROCEEDINGS OF THE BOARD OF SUPERVISORS October 6, 2015

The Board of Supervisors of Cerro Gordo County, Iowa, met in regular session pursuant to adjournment. Present: Chairman Phil Dougherty, Supervisor Jay Urdahl, Supervisor Casey Callanan and various members of the public.

Dougherty convened the meeting at 10:00 a.m. Callanan made a motion, with Urdahl seconding, to approve the September 29, 2015 regular session minutes and today's agenda. Motion passed unanimously.

Urdahl made a motion, with Callanan seconding, to approve the job description for Assistant to the Engineer. Motion passed unanimously.

Urdahl made a motion, with Callanan seconding, to approve the claims. Motion passed unanimously.

Callanan made a motion, with Urdahl seconding, to approve payroll change for Jeffrey Bryant in the Sheriff's Department to \$27.34 per hour effective October 5, 2015 and \$27.75 per hour effective January 1, 2016. Motion passed unanimously.

Callanan made a motion, with Urdahl seconding, to approve the County and City Assessor's Recommendations for AY2015 Homestead Credits, Disabled Veteran Homestead Credits, and Military Exemptions. Motion passed unanimously.

Urdahl made a motion, with Callanan seconding, to approve the Sheriff and Clerk's monthly report of fees and the County Recorder's quarterly report of fees. Motion passed unanimously.

Urdahl made a motion with Callanan seconding to adopt Resolution 2015-103, Whereas, it is desired to transfer monies from the General Fund to the Public Health; and, Whereas, it is desired to transfer monies from the Rural Services Fund to the Secondary Roads Fund; and, WHEREAS, said operating transfers are in accordance with Section 331.432, Code of Iowa; and, Now Therefore, Be It Resolved by the Board of Supervisors of Cerro Gordo County, Iowa, as follows: The sum of Eight hundred thirty thousand nine hundred seventy-nine 00/100 (\$830,979.00) dollars is ordered to be transferred from the General Fund to the Public Health Fund, effective September 29 , 2015. (Transfer #1350). The sum of One million 00/100 (\$1,000,000.00) dollars is ordered to be transferred from the Rural Services Fund to the Secondary Roads Fund, effective September 29, 2015. (Transfer #1349). The Auditor is directed to correct his books accordingly and to notify the Treasurer of this operating transfer. Motion passed unanimously.

Callanan made a motion, with Urdahl seconding, to approve reports from the Zoning Director and Environmental Health Service Manager concerning the Manure Management Plan filed by Indigo Family Farms (Ashley's Farm) forward them to the DNR. Motion passed.

Urdahl made a motion, with Callanan seconding, to proclaim October as Domestic Abuse Awareness month. Motion passed unanimously.

Urdahl made a motion, with Callanan seconding, to acknowledge receipt of Second Judicial District Department of Correctional Services Annual Report for Fiscal Year 2015. Motion passed unanimously.

Callanan made a motion, with Urdahl seconding, to approve Cerro Gordo County to be the Applicant for CDBG for Prairie Ridge Project. Motion passed unanimously.

Urdahl made a motion, with Callanan seconding, to adjourn at 10:23 a.m. Motion passed unanimously.
