NOW, THEREFORE, BE IT RESOLVED by the Cerro Gordo County Board of Supervisors that Ordinance No. 15, Article 5.2, of the Zoning Ordinance of Cerro Gordo County, Iowa, hereby amended by changing the district boundaries thereof so as to change the classification of the following described property from A-1 Agricultural District to the A-2 Agricultural Residence District on the following described real estate, to-wit:

Parcel A containing 9.00 acres located in part of the Southeast Quarter of the Southwest Quarter of Section 33, Township 96 North, Range 20 West of the 5th P.M., Cerro Gordo county, Iowa as described in the Plat of Survey dated August 19, 2021 and recorded on August 25, 2021 as Document No. 2021-6505. Motion passed unanimously.

Latham moved with Watts seconding, to approve Final Pay Voucher for HMA Resurfacing Project FM-C017(111)—55-17 and authorize the Chair to sign. Motion passed unanimously.

Latham moved with Watts seconding, to authorize the Chair to sign Road and Street Maintenance 28E Agreement with the City of Mason City and the County Line 28E Agreement with Hancock County. Motion passed unanimously.

Watts moved with Latham seconding, to authorize the Chair to execute the Certification for CIS HUD Grant. Motion passed unanimously.
