PROCEEDINGS OF THE BOARD OF SUPERVISORS March 29, 2022

The Board of Supervisors of Cerro Gordo County, Iowa, met in regular session pursuant to adjournment. Present: Chairman Chris Watts, Vice Chairman Tim Latham, Supervisor Casey Callanan, and various members of the public.

Chairman Watts convened the meeting at 10:00 a.m.

Callanan moved with Latham seconding, to approve today's agenda and the minutes for the March 22, 2022 regular session. Motion passed unanimously.

Public comment session was held.

Latham moved with Callanan seconding, to approve claims. Motion passed unanimously.

Callanan moved with Latham seconding, to approve the Clerk's Monthly Report of Fees. Motion passed unanimously.

Callanan moved with Latham seconding, to adopt Resolution 2022-36, WHEREAS, the Board of Trustees for the Clear Lake Sanitary District has requested that the term of one of the Trustees be extended for an additional two (2) years, and WHEREAS, under Iowa Code Section 358.9 the Board of Supervisors for Cerro Gordo County have the authority to establish the term for a Trustee, and WHEREAS, this would provide that three (3) of the positions on the Board of the Clear Lake Sanitary District would be on the ballot for the 2022 general election and two (2) positions would be on the ballot for the 2024 general election, and WHEREAS, the Board of Supervisors have reviewed the request from the Clear Lake Sanitary District; NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors for Cerro Gordo County, Iowa:

Section 1. The Cerro Gordo County Board of Supervisors hereby declares the term for Mark H. Bale, as trustee for the Clear Lake Sanitary District shall be extended for an additional two (2) years.

<u>Section 2</u>. The term for all Trustees of the Clear Lake Sanitary District shall be four (4) year terms except for the extended term provided herein. Motion passed unanimously.
