Chairman Callanan convened the meeting at 10:00 a.m.

Meacham Ginapp moved with Watts seconding, to approve today's agenda and the minutes for the June 12, 2023 special session, June 12, 2023 regular session, and June 14, 2023 special session. Motion passed unanimously.

Meacham Ginapp moved with Watts seconding, to adopt Resolution 2023-64, WHEREAS, the Cerro Gordo County Planning & Zoning Commission, after study, has recommended that the change of zoning classification of a certain area hereinafter described upon the application of Aaron R. Donaldson, be made, and WHEREAS, the final public hearing has been held with notice as required by law. Watts moved with Meacham Ginapp seconding, to adopt Resolution 2023-65, WHEREAS, recent changes to recycling markets have caused disruptions to local efforts, leading to the need to consider the overall state of recycling in our region; and WHEREAS, the Landfill of North Iowa is the 28E intergovernmental solid waste agency for our region, and Cerro Gordo County is a member in good standing of this partnership; and WHEREAS, the Landfill of North Iowa is taking leadership on the recycling issue with a committee established to examine options and develop costeffective, efficient, and forward-thinking solutions for our region; and WHEREAS, Cerro Gordo County wishes to indicate its support for this initiative. NOW, THEREFORE, BE IT RESOLVED BY THE CERRO GORDO COUNTY BOARD OF SUPERVISORS OF MASON CITY, IOWA:

Section 1. The Cerro Gordo County Board of Supervisors indicates its support for the establishment of the Landfill of North Iowa's recycling committee and the Landfill of North Iowa Board of Directors' efforts to develop sensible policy for recycling in our region.
