## **APPLICATION CHECKLIST AND REQUIREMENTS**

Below is information regarding requirements for the specific types of uses that require a Temporary Use Permit.

#### **BLOCK PARTIES IN RESIDENTIAL DISTRICTS**

A Temporary Use Permit is required for a block party in occurring in a residential district in which there is a live music performance and/or a closure of a public road. Typical social events that are incidental to a residential use (e.g. family gathering, graduation party, potluck, etc.) do not otherwise require a permit.

#### Application Checklist

- Completed application
- \$25.00 non-refundable application fee
- Signature page signed by a minimum of 75% of adjacent property owners (block party with road closure only)

#### Requirements

- Submit to the Planning and Zoning Office at least 14 days before the scheduled event date
- Notify Sheriff's Department 24 hours before event
- Provide adequate trash receptacles and remove all trash and refuse following event
- Live music only: Hours of operation no later than 10 p.m. Sunday-Thursday; or, 11 p.m. Friday and Saturday, or Sunday that is followed by a federal holiday
- Block party with road closure only:
  - o Obtain "Work in the Right-of-Way Permit" from County Engineer's Office
  - Only permitted on "local roads" as classified by the Iowa DOT with speed limit of 25 mph or less
  - Block off road to regular traffic; BUT must allow adjacent property owners access to their property
  - o Repair any damage to the public road caused by event at permittee's expense

#### **Temporary Occupancy of Travel Trailers**

A Temporary Use Permit is required for the occupancy of a travel trailer outside of a travel trailer park. A permit will only be issued for a maximum of 14 days. A Special Use Permit for a travel trailer park may otherwise be required as provided for in the Zoning Ordinance.
