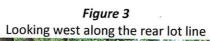

Looking at the proposed location for the addition



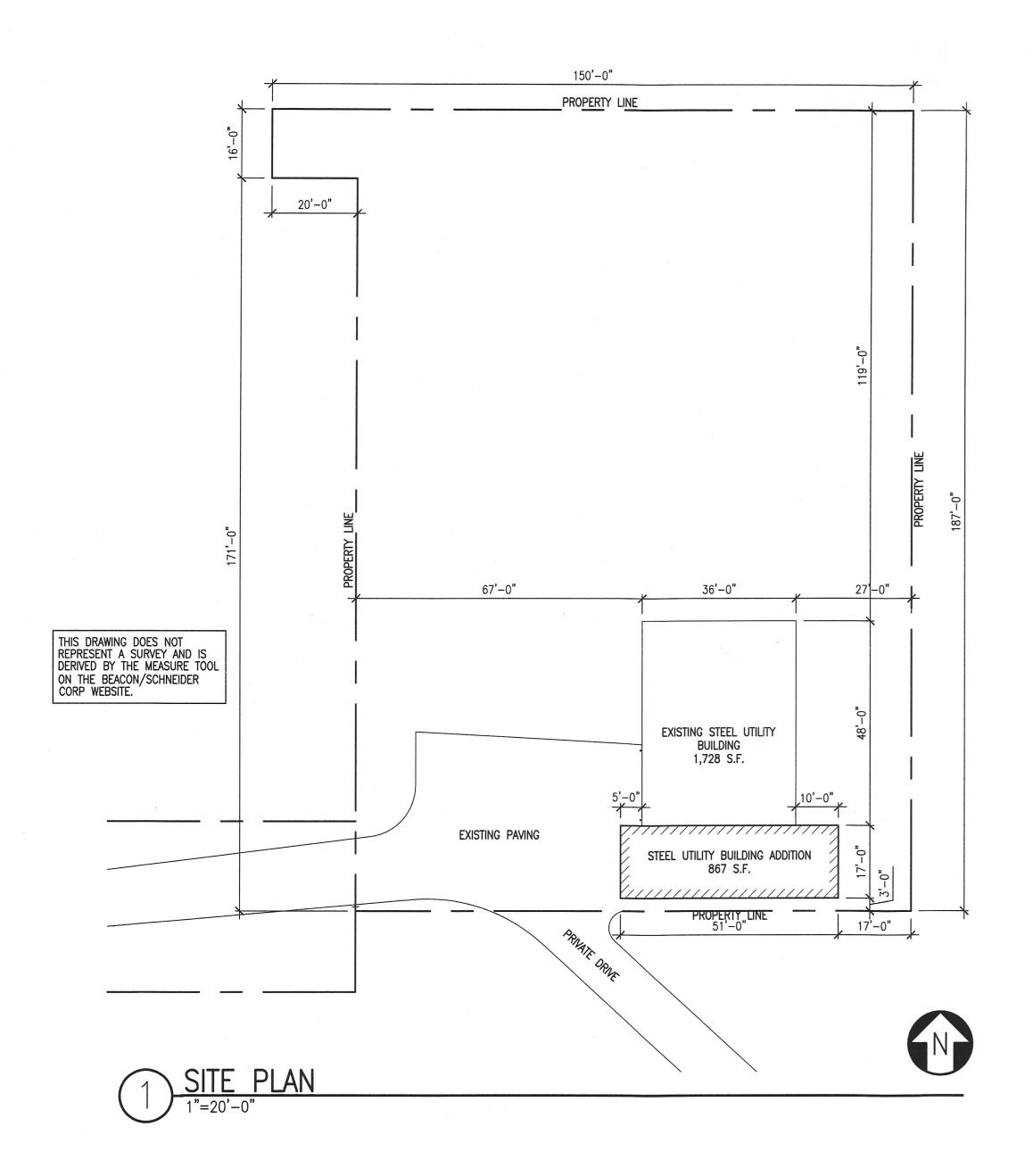

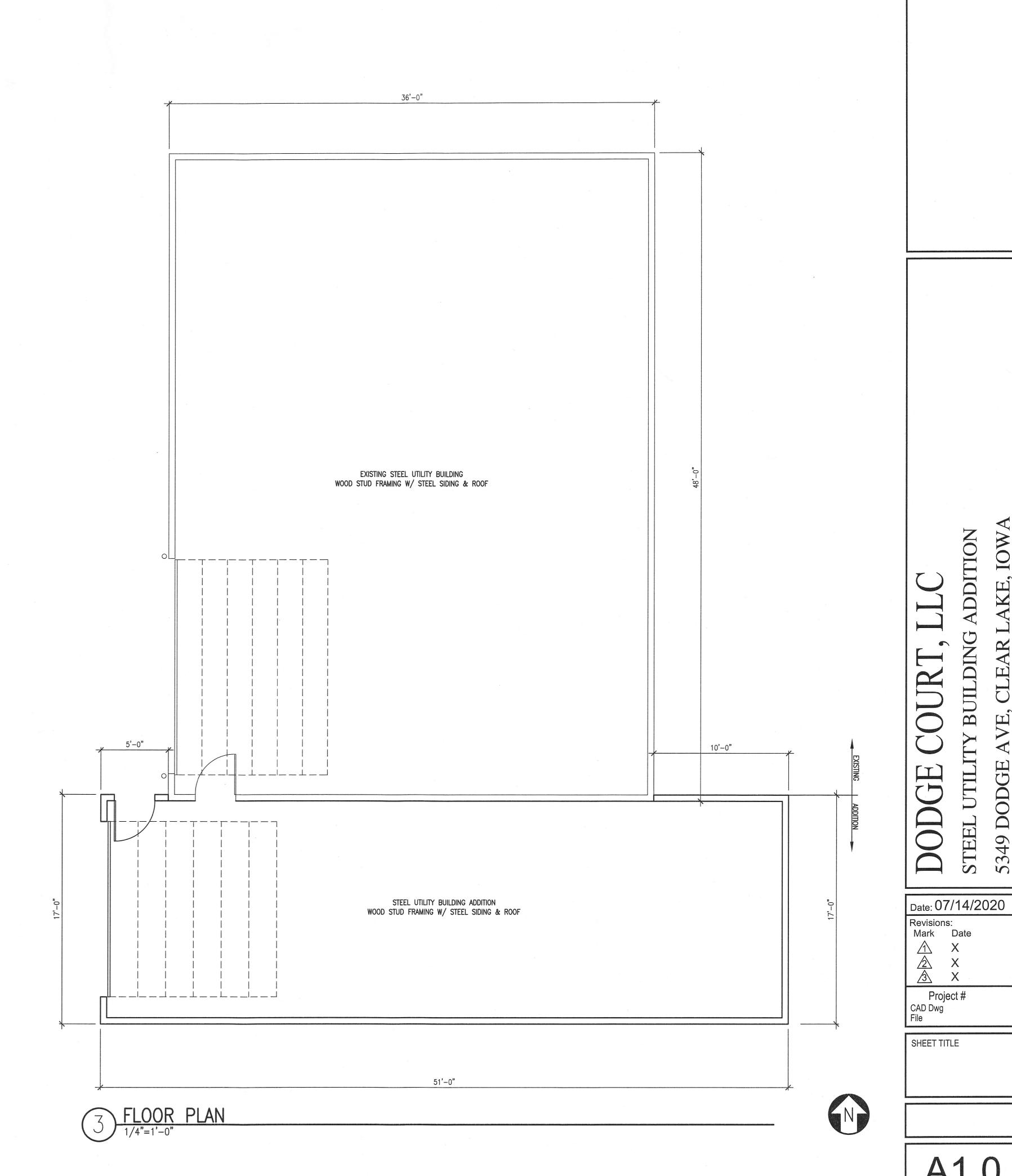
